





Creative Meeting Actions

Celebrate being in the space with other creative people.

Engage with everyone's presence as a gift.

Acknowledge that together we know a lot.

Enter the conversation with curiosity and inquiry.

Share your idea and trust that it will be heard.

Use "I" statements.

Focus your language on the task at hand.

Hold one another accountable with care.

Apply "Yes, and!" - "I hear your idea and I'm going to add to it!" **Balance** speaking and listening.

We encourage avoiding the use of pronouns in public meetings. Please introduce yourself by name when speaking and refer to each other by name during the meeting.



MSAC Professional Development

- Envision topic-specific interactive spaces based on feedback and requests such as Financial Management, Marketing Strategies, Strategic Planning, Board Engagement, and more.
- **Coffee with Ken** Tuesday morning space for updates from the MSAC Executive Director and constituent peer-to-peer sharing.
- **Creative Conversations** discipline-specific, budget size-specific gatherings for resource sharing and ideation.
- **Networking sessions** are held for topic-specific and informal interactions.
- **Regional Arts Summits** focus on artists, organizations and activities of five specific areas of the state, offering learning and networking opportunities.
- **2021 Maryland Arts Summit** will be held virtually on June 3 and 4, 2021.

From March, 2020 - May, 2021, 9,790 participants attended 264 virtual professional development offerings by MSAC!

- **Compensation Provided for Service** (\$50/training, \$100/panel meeting, \$200/review period + additional fees for different programs.)

What is the Independent Artist Awards?

- Recognizes achievement by Maryland Artists making work independently of an organization or institution.
- Awards are accompanied by a grant (\$2,000; \$10,000; \$15,000) that encourages artistic growth and sustained practice.
- Program used to be administered by the Mid-Atlantic Arts Foundation. 2020 was the first year MSAC fully administered the program from start to finish.



What is the Independent Artist Awards?

- Three Year Cycle for applicants in primary categories: Performing, Visual/Media, Literary Arts
- Primary Categories rotate each year
 - Literary Arts FY22
 - Performing Arts FY23
 - Visual/Media Arts FY24
- Applicants can only apply to the Primary Category and are reviewed by a panel for consideration.
- Applications are due on July 1, 2021 at 5pm



Helpful Hints!

- Only completed work may be submitted
 - Works in progress and project proposals are not considered eligible.
 - For the purposes of this program, "complete" is considered to be the point at which the work is ready for public presentation.
 - "Completed" does not equal "published"
 - Unlike the Creativity Grant or other programs, the application is not for explaining how the Award, if granted, would be used



Eligibility (Abbreviated)

- Must be a Maryland resident
- Must be 18 years of age or older
- Collaborative groups must be composed of artists who are 18 years or older. 50% of artists in a collaborative group must meet the residency requirement
- Applicants cannot be in school (high school, undergrad, or graduate in any artistic discipline)
- Review all guidelines carefully on page 6 of the guidelines to verify eligibility



What falls under the Literary Arts category?

Examples include (but are not limited to):

- Fiction
- Non-fiction
- Poetry
- Scripts and screenplays
- Children's literature
- Graphic literature

Types of Awards

<u>\$2,000 Regional Awards</u> - awarded in each region to encourage an the pursuit of promising work by an individual artist or collaborative group.

<u>\$10,000 Regional Awards</u> - awarded in each region to recognize notable artistic achievement by an individual artist or collaborative group.

All \$10,000 Regional Award winners will be eligible for the State Award(s):

<u>\$15,000 State Award(s)</u> - awarded to up to two (2) artists or collaborative groups per year to recognize outstanding artistic achievement

An artist may receive up to three \$2,000 Regional Awards, two \$10,000 Regional Awards, and one State Award in their lifetime.



IAA Application

Application includes:

- Applicant Contact Information
- Collaborator Information (for collaborative groups)
- Creative Process Statement (100 word limit)
- Up to 8 work samples with technical information and work sample description

All applications are completed in Smart Simple (online grants platform)



IAA Application - Creative Process Statement

This statement should convey to the panel information that further informs any additional processes, inspiration, intention, philosophy, evolution of style, current direction of the artist's work that is being submitted for review (100 word limit).



IAA Application - Work Samples

Applicants may provide up to eight work samples in whichever file type (audio, image, video, or PDF) or combination of file types they feel best showcases their work. Technical information may be provided for each work sample.



IAA Application - Work Samples

- All files types and sizes will be accepted.
- The total combined length of all audio and video files may not exceed **10 minutes per application**.
- The total combined length of manuscripts and compositions may not exceed 20 pages per application.
- See pages 9 and 10 of guidelines for specific info on file type recommendations



Helpful Hint!

- Each work sample should be its own file/upload
 - For example, 4 poems = 4 work samples
 - Do not combine work samples into one combined PDF
 - Do make sure the entire work sample (i.e. an 8 page excerpt from a novel) is included in one PDF (and not 8 PDFs, one for each page)



Application Review Process

Application is open now through **Thursday, July 1st at 5pm** Applications received after the deadline will not be accepted

Each application submitted by July 1, 2021 will be reviewed by the MSAC staff for eligibility from July - August 2021.



- Prior to the Regional Panel meetings, applications will first be reviewed by panelists on their own time the Round 1 Scoring Rubric.
- This review will happen in approx. September October
- Average panel scores determine which applications advance to Round 2.
- An application can receive a total of 15 points per panelist.



Round 1 Rubric - an Excellent to Outstanding score of 15 total points will include:

- Clear evidence of outstanding achievement in presenting promising and/or engaging work (5 pts)
- Excellent communication of creative process (5 pts)
- The described creative process/vision are very clearly evident in the work samples (5 pts)



- Those applications that score high enough will move to Round 2 of reviews, which takes place at the Regional Panel Meetings.
- Regional Panel Meetings will occur in late November and early December, 2021.
- An application can receive a total of 15 points per panelist in Round 2.



Round 2 Rubric - an Excellent to Outstanding score of 15 total points will include:

- Work samples provide evocative experiences and heightened sensations based on the intention. (5 pts)
- Work samples communicate collective meaning that goes beyond the artist's(s') perspective and experience. (5 pts)
- There is a strong connection between the concept statement and the work samples demonstrating contemporary perspectives (remaining open, fluid, transparent, subject to influence, and able to hold contradiction)



Application Review Process - State Panel

Those applicants recommended for a \$10,000 Regional Award will move forward to the State Panel Meeting, for consideration of an additional \$15,000 State Award, which is awarded to up to two artists/collaborative groups.

Panelists will use the two rubrics from Round 1 and Round 2 to guide the discussion of each applicant. Panelists will make funding recommendations based on the discussion. Those with a majority of recommendations will be recommended for the State Award(s).



Panel Meetings

In accordance with Maryland's Open Meetings Act, IAA panel meetings are open to the public for observation only. Artists are encouraged to attend and hear the panel's comments about applications.

Meeting information, including dates/times/location, will be available on msac.org in the fall.



Notification of Awards

Applicants will be notified of award decisions in writing no later than **March 1, 2022**.

MSAC notifies all applicants, whether they receive an award or not.
